- Weanling \$50.00 (if stallion is nominated in KWHBIF)
- \$100.00 (if stallion is *not* nominated in KWHBIF)
- Yearling \$100.00 (if stallion is nominated in KWHBIF)
- \$200.00 (if stallion is *not* nominated in KWHBIF)
- 2 Year old \$200.00 (if stallion is nominated in KWHBIF)
- \$400.00 (if stallion is *not* nominated in KWHBIF)
- 3 Year old and up \$300.00 (if stallion is nominated in KWHBIF)
- \$600.00 (if stallion is *not* nominated in KWHBIF)

Any horse being nominated that is 3 years old and over must have printed on their papers what state they were born in.

Eligibility:

- Foal must be born in Kentucky
- The dam must be in Kentucky 45 days prior to foaling
- Foal must be registered with TWHBEA

Nominations must be made by June 1st

Any weanling born after June 1st has 60 days to nominate to be eligible for current show season

(~~\$10.00 of the nomination fee will be used for association fee for the KWHBIF~~)

"Any attempt in connection with the Kentucky Walking Horse Breeders Incentive Fund to provide false or misleading information to KY breed affiliates or government officials, or to otherwise engage in fraudulent activity, shall result in appropriate disciplinary action by the Kentucky Walking Horse Breeders Incentive Fund and the application of all administrative, civil and criminal penalties that may apply." Any owner/trainer who is caught nominating doing so will be banned for life from the Kentucky Walking Horse Breeders Incentive Program and reported to the State of Kentucky.
